

Future Magpies Ticket Promotion – Terms and Conditions

1. This webpage contains the terms and conditions for the *Future Magpies Ticket Promotion* (“Promotion”). Participation in this Promotion is deemed acceptance of these Terms and Conditions.
2. The promoter is the Collingwood Football Club (ABN 89 006 211 196) of Corner Olympic Boulevard & Batman Avenue, Melbourne, VIC 3004, (“Promoter”).
3. Promotion commences at 12:01am on Monday 14 April and closes at 11:59pm 7 days prior to round 24 Collingwood v Melbourne. (“Promotional Period”). All times indicated in these Terms and Conditions are in AEST.
4. The promotion only applies to the **Future Magpies** Ticketing type and the promotion includes two reserved seat tickets per unique code to home games at no cost.
5. The ticketing offer and unique barcode works as follows:
 - The unique code on your Future Magpies Ticket Promotion can be used for one game to redeem two free reserved seat tickets
 - Tickets are subject to availability - a limited number of tickets are available for each game and will be allocated on a first come, first served basis.
 - Tickets only include Collingwood home games at the MCG and Marvel Stadium but excluding 'fully ticketed' games in rounds 4, 7, and 12.
 - Up to 2 additional tickets can be purchased for a fee, subject to availability.
 - Once the unique code has been used, the game chosen cannot be changed.
 - Tickets redeemed but not used to attend will be forfeited - replacement codes cannot be provided.
6. This offer cannot be applied retrospectively.
7. There will be a “redemption-deadline”, whereby the recipient must redeem the seats to the game they’d like to attend, 7-days out from that specific game.
8. This offer is only valid to new registrations with their unique code.
9. This ticketing offer is only valid for the Collingwood 2025 AFL Season.

10. This offer will not apply to any other membership types or categories other than those listed above.
11. This offer is not valid in conjunction with any other offer, promotion or discount.
12. Subject to applicable laws, Collingwood Football Club reserves the right to cancel or change the promotion at any point without prior notice.
13. This ticketing offer will be subject to full ticketing terms and conditions available [here](#).
14. The Promoter will also use and handle personal information (PI) as set out in its Privacy Policy, which can be viewed [here](#). The Promoter may, for an indefinite period, unless otherwise advised, use the PI for promotional, marketing, publicity, research and profiling purposes, including sending electronic messages or telephoning the member. The Privacy Policy also contains information about how members may opt out, access, update or correct their PI, how they may complain about a breach of the Australian Privacy Principles or any other applicable law and how those complaints will be dealt with. All entries become the property of the Promoter. Unless specified otherwise, the Promoter may disclose entrant's personal information to any entity outside of Australia (see Promoter's Privacy Policy for details).
15. These terms and conditions are governed by the laws of Victoria, and you unconditionally submit to the non-exclusive jurisdiction of the Courts having jurisdiction there.

To the fullest extent permitted by law (including without limitation the Australian Consumer Law) the Promoter shall in no circumstance be liable to you for any direct or consequential losses or any loss (whether direct or indirect) arising out of your purchase of or participation in Club membership, including without limitation from the loss or suspension of your membership card or your ability to attend all or any Collingwood games or enter a venue where a Collingwood game is occurring, except to the extent the loss is caused by the Club's breach of these terms and conditions, its negligence or wilful default.
