### Membership Promotion – Pies Double Pass – Terms and Conditions

1. This webpage contains the terms and conditions for the *Pies Double Pass* promotion pursuant to which discounted access to the Standard Reserved Bay Membership will be made available (“Promotion”).

#### 1a. The Standard Reserved Bay Membership includes

- Access to redeem a \$0 ticket into our Level 1 Reserved Bay seating area for Collingwood FC Home games in 2025\*
- A 2025 Member Pack
- Priority access to purchase a ticket to weeks 1-3 of the 2025 AFL Finals Series if Collingwood FC is a participating team
- Priority 3 ballot access to register to purchase a 2025 Grand Final ticket if Collingwood is a participating team\*
- 10% Club merchandise discount

*\*As a reduced-access (2-game) version of the Standard Reserved Bay membership, adding Social Club access will not elevate the promotional Pies Double Pass package's Grand Final ballot access from Priority 3 to Priority 2.*

2. Participation in the Promotion is deemed acceptance of these Terms and Conditions.
3. The promoter is the Collingwood Football Club (ABN 89 006 211 196) of Corner Olympic Boulevard & Batman Avenue, Melbourne, VIC 3042 (“Promoter”).
4. Promotion commences at 12pm on Tuesday 22 July 2025 and closes at 5:00pm on Friday 29 August 2025 (“Promotional Period”). All times indicated in these Terms and Conditions are in AEST.
5. The Promotion only applies to the **Standard Reserved Bay** Membership type.
6. The promotional price for the **Standard Reserved Bay** memberships will be as follows (including GST):

Concession - \$89

7. Payment must be made in full at the time of purchase. Monthly instalments are not available for this offer.
8. This offer cannot be applied retrospectively.

10. The Promotion is only valid for the 2025 Membership Season. Members will be offered the chance to renew the membership at full price during the renewal period for the 2026 Season.

To the fullest extent permitted by law (including without limitation the Australian Consumer Law) the Promoter shall in no circumstance be liable to you for any direct or consequential losses or any loss (whether direct or indirect) arising out of your participation in the Promotion, purchase of or participation in Club membership, including without limitation from the loss or suspension of your membership card or your ability to attend all or any Collingwood games or enter a venue where a Collingwood game is occurring, except to the extent the loss is caused by the Club's breach of these terms and conditions, its negligence or wilful default.
