

Standard Reserved Bay Promotion Terms and Conditions

1. This webpage contains the terms and conditions for the *Standard Reserved Bay Promotion* (“Promotion”). Participation in this Promotion is deemed acceptance of these Terms and Conditions.
2. The promoter is the Collingwood Football Club (ABN 89 006 211 196) of Corner Olympic Boulevard & Batman Avenue, Melbourne, VIC 3004 , (“Promoter”).
3. Promotion commences at 5:00pm on Friday 25 April and closes at 11:59pm on Sunday 31 August (“Promotional Period”). All times indicated in these Terms and Conditions are in AEST in 2025.
4. The promotion only applies to the **Standard Reserved Bay** Membership type and the promotion includes a discount for 2025 only.
5. The price for the **Standard Reserved Bay** membership will be as follows:
